Sai Ram limited is an agricultural co-operative owned by more than 750 citrus growers. The company produces canned and bottled Juice, Juice drinks and food products at distribution centres spread across			
		Sai Ram limited was managing transportation operations internally, but the company decided it wanted to focus on its core competency, which according to its director of logistics is "Maintaining our leadership in the shelf stable juice drink category". The company also wanted to centralize			
		its transportation operations. Looking carefully at the issue of overall performance in the logistics and transportation areas, it was found that there was a significant amount of variability in its operations. For purposes of informality and control, a major priority was attached to centralization of its			
		logistics operations. In addition, Sai Ram limited wanted to be able to reach market it didnot already have to access to, which would require expansion of its logistics network. According to the logistics director, an analysis was undertaken to
